The undersigned Parent/Guardian is allowing student participation in these activities with the knowledge that, as with any activity, physical injury is a possibility and hereby agrees to accept any and all risk of injury. We hereby agree that this event is organized by volunteers and that we release any and all organizers and volunteers of this event from any claim that may arise out of student participation. We also agree that we will not make a claim against, sue or attach the property of the Grad Night Committee or any volunteer/member thereof. We also understand the event will observe a zero tolerance policy and that each student participant may be searched for illegal and inappropriate items.

We have carefully read this agreement and fully understand its contents. We are aware that this is a Waiver and Release of Liability and a contract between us and the Grad Night Committee volunteers and the Orange Unified School District. All students will follow the Orange Unified School District's Code of Conduct that is enforced during school activities.
